The meltdown incident that occurred at the Fukushima Daiichi Nuclear Power Plant has not ended (as of May 1, 2013). Nuclear reactors formerly in operation at the Fukushima NPP were produced by GE, HITACHI, and TOSHIBA.

Moreover, the "Act on Compensation for Nuclear Damage" in Japan prescribes that "a power supplier (or in this case Tokyo Electric Power Company [TEPCO]) should be exclusively required to take whole responsibility on any nuclear damage caused by an NPP accident." In other words, no reactor manufacturers are required to take any responsibility under the specified Act. If that's so, won't such a monstrous industry continue to exist even in the aftermath of the Fukushima incident?

Therefore all of us at No Nukes Asia Actions-Japan (referred to as NNAA) have planned The Reactor Suppliers Lawsuit to take action against the reactor manufacturers. We plan to file the litigation with the Tokyo District Court (TDC) in November 2013.

Our objectives:

- ☆ To make the "Act on Compensation for Nuclear Damage" a social issue.
- ☆ Claim the above NPR manufacturers to give up "their current monstrous business (called NPP business)" and transform it into environmentally-friendly one.
- ☆ Deliver our message worldwide, appealing the destructive nature of the NPR Monster to the public, as to "prevent such a monster from manifesting".

Note:

- * Our specific claim to the TDC in the lawsuit includes: "Claiming 100 yen per plaintiff against the 3 NPR manufactures as compensation for spiritual damage of the world's plaintiffs, suffering said damage through watching the images of the Fukushima meltdown incident via mass media or the like.
- * NNAA is gathering plaintiffs from all around the world. Information about defense lawyers for the plaintiffs is also available upon request.

However, the law prescribes articles far from the common sense of the public. In case of a nuclear accident, only the power operator is to be held responsible! Does such a law really comply with the Japanese Constitution?

Common Name	FIRE POO, The Meltdown Monster
Scientific name	Monstrum Liquesco Deorsum, Combustum Poo
Height	Approx. 55m (61 yards)
Habitat	Some 600 locations on the planet (as of May 2013) In its earliest stage, it existed in the former Soviet Union, Great Britain and North America. Later, its proliferation slowed down in both Europe and North America, though its propagation is still continuing in much of Asia, particularly East Asia.
How it lives	Mainly feeds on U238 with U235 mixed in. Some others feed on a mix of U and Pu239; those in India feed on thorium and turn it into U233. Occasionally goes out of control, "breathing fire" (explosions or meltdowns) and "burning poo" (corium) Even when under control, its "poo" is deadly toxic and lasts for millions of years. Probably, the first incidence of a FIRE POO breathing fire took place in Idaho, USA in 1955. Later, such hazards hit Pennsylvania, USA, Ukraine and Japan.
Breeding	A deadly apocalyptic monster. We should never let them exist on our planet. Still, there are some diehard pro-nukes addicted to breeding this deadly monster, with plans to turn it into a closely-related species, "Meena Gorothy" (a play on the Japanese word 皆殺し [mina-goroshi], meaning "genocide").
DNA phyloanalysis	Fire Poo is an immediate pseudo-differentiation from the destructive nuke monster, "Meena Gorothy" (Genecidio nucleae). We call it pseudo-differentiation, since it all began with the hocus-pocus known as "Atoms for Peace."
